#### **CHANGES / REQUIRMENTS**

Does OSHA require everyone to be trained in first aid?

OSHA **recommends**, but **does not require**, that every workplace include one or more employees who are trained and certified in first aid, including CPR. The other option for employers is to rely upon the reasonable proximity of an infirmary, clinic or hospital.

#### Is CPR training required by OSHA?

**OSHA** Compliance for **CPR** and First Aid Training Employers are **required** by **OSHA** standard 29 CFR 1910.151 to have a person or persons adequately trained to render first aid for worksites that are not in near proximity to an infirmary, clinic, or hospital.

#### Is AED training required by OSHA?

OSHA does not have any legally-binding statutes governing the use or presence of defibrillators in the workplace, though it does require that workplaces employ people trained in first-aid care and in CPR if the workplace is not in close proximity to a hospital or other health care facility. While OSHA recommends that workplaces consider purchasing a defibrillator as part of their first-aid kit and training employees in their use, there is no requirement to do so.

#### How often is training good for?

CPR certificates expire after two years. The American Safety & Health Institute (ASHI) recognize all CPR certificates as valid for up to two years from the course completion date and two years for first aid training. The expiration date is listed on the certificate and on an individual's CPR card.
